# release and rules of conduct

Please follow these rules and guidelines while in the kennel or play areas at Shaw Pit Bull Rescue, Inc.

- Enter the kennel area in calm manner, no loud talking, waving arms, or yelling.
- Be sure children do not run around, scream, or act unruly while in the kennel area.
- Check with a member of the PitCrew to make sure it is ok to approach a dog before doing so. Management are the only ones allowed to open kennels.
- Be sure to close AND secure all gates and doors as soon as you are through them, including any opened kennels and outside gates.
- Approach dogs slowly, calmly, and use a soothing voice; do not tower over them.
- If a dog is giving "unwelcoming" signals (stiff body or trembling, cowering, head low, a hard stare or wide eyes, growling, lunging, showing teeth, etc.) immediately stop what you are doing and back away
- Should a dogfight start, seek help immediately. Do NOT attempt to break up a fight.

I also hereby release and forever discharge Shaw Pit Bull Rescue, Inc. from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency while at Shaw Pit Bull Rescue, Inc. I understand that expenses from possible injury will be paid by me, personally, and not by Shaw Pit Bull Rescue, Inc.

By signing below, I express my understanding and intent to enter into this Release and Waiver of Liability willingly and voluntarily. I also understand that any violation of the rules of conduct above may lead to immediate dismissal from Shaw PBR.
